**Subject: Results of by-election held on 15 June 2006 and Vacancies on Committees, Outside Bodies, etc**

### **1. Purpose**

#### **1.1 This report:-**

- (a) informs the Council of the results of the recent local government by-election held on 15 June 2006 to elect a Councillor to represent Ward 16 – Dumbarton West; and
- (b) seeks the nomination of elected members to fill vacancies on various committees, outside bodies, etc.

### **2. Background**

#### **2.1 Following the resignation of Councillor Joseph Pilkington (Ward 16 – Dumbarton West) a by-election was held on 15 June 2006. The Council is asked to note the results of the by-election as follows:-**
