Welfare Rights and Money Advice Services

Benchmarking Authorities – Service Models Overview

As noted in the 3.3.5 in the report, there are 4 areas of Benchmarking Criteria and Benchmarking Data for comparison which have been identified for evaluation, together with comment on the organisation of service provision for benchmark authorities - all of these is as follows:

1. West Dunbartonshire Council

Services provided via Social Work Service, with first tier service provision within the Social Work Area Teams as first point of contact for Duty intake and support to staff. Access for all residents to Welfare Rights Officers and Money Advisors through Area Teams, referrals from other services / organisations and self-referrals. Specialist WRO's operate within Health, Education, Joint Mental Health & Learning Disability Teams, with 5 FTE's responsible for claim progression work and 2 FTE's carrying out Appeal Representation. Total FTE's for service is 36.55.

2. Renfrewshire Council

Service provided across to any resident. A recent review outcome was to implement hub and spoke model. With one base (reduced from three), team require to 'book' desks at base and organise desks elsewhere within the Council and/or work from home, where appropriate, whilst providing outreach surgeries. Total FTE's for service is 25.21.

3. North Lanarkshire Council

Service provided via Social Work, with Welfare Rights as second tier service. Only Social Work clients can access Welfare Rights Services, with the exception of Appeals Representation, which can be accessed by any resident. No Money Advice service provision offered by LA Welfare Rights Service. Total FTE's for service is 32.00.

4. West Lothian Council

Service provided across local authority area with any resident able to access. Similar types of service provision as within West Dunbartonshire (Welfare Rights, Money/Fuel/Housing advice etc). Very high levels of financial gains / debt managed etc, requires further scrutiny before comparison. Total FTE's for service is 34.00.

North Ayrshire Council

Service provided via Social Work, with Welfare Rights as second tier service. Only Social Work clients can access Welfare Rights Services, with the exception of Appeals Representation, which can be accessed by any resident. Money Advice provided. Total FTE's for service is xxxx (awaited).

6. Glasgow City Council

Service provided via Social Work, with Welfare Rights as second tier service. Only Social Work clients can access Welfare Rights Services, with the exception of Appeals Representation, which can be accessed by any resident. No Money Advice service provision offered by LA Welfare Rights

Service. Further Welfare Rights Officers / Money Advisors (3/4) based and line managed in each CHCP and not included in central budget costs. Total FTE's for service is 22.50.
