**Subject: Awarding of Contracts during the period December 2005 to March 2006**

#### **1. Purpose**

- 1.1** To advise the Committee of contracts awarded under delegated authority during December 2005 to March 2006.

#### **2. Background**

- 2.1** At the Tendering Committee meeting of 7 December 2005, a report by the Director of Housing and Technical Services was submitted seeking to establish a mechanism to enable the prompt issue of letters of acceptance to tenderers between December 2005 and March 2006.

The Committee agreed to:-

- (a) Delegate authority to the Director of Housing and Technical Services in consultation with the Convener of Housing and Technical Services together with the Director of Corporate Services to accept the most economically advantageous tenders returned during December 2005 to March 2006.
- (b) Instruct the Director of Housing and Technical Services to submit a report to a future Committee meeting confirming those contracts awarded during the period December 2005 to March 2006.
