# MINUTES OF PREVIOUS MEETING

The Minutes of Meeting of the Alexander Cross Cameron Bequest Committee held on 4 October 2017 were submitted and approved as a correct record.

#### APPLICATION FOR FUNDING FROM CLYDEBANK G81 TRUST

A report was submitted by the Strategic Lead – Resources requesting consideration regarding an application for funding received from Clydebank G81 Trust.

After discussion and having heard the Business Unit Finance Partner in further explanation of the report and in answer to Members' questions, Councillor McNair, seconded by Provost Hendrie, moved:-

That a grant of £2,400 be awarded to the Clydebank G81 Trust.

As an amendment, Bailie Agnew, seconded by Councillor Brown, moved:-

That the Committee award nil grant to the Clydebank G81 Trust as it was considered that the application did not meet the criteria of the Alexander Cross Cameron Trust.

On a vote being taken, 3 Members voted for the amendment and 4 Members voted for the motion which was accordingly declared carried.

## APPLICATION FOR FUNDING FROM FAIFLEY COMMUNITY COUNCIL

A report was submitted by the Strategic Lead – Resources requesting consideration regarding an application for funding received from Faifley Community Council.

After discussion and having heard the Business Unit Finance Partner in further explanation of the report and in answer to Members' questions, Councillor O'Neill, seconded by Councillor McNair, moved:-

That a grant of £5,000 be awarded to Faifley Community Council, on the basis that it was anticipated that this would be the last time a grant for funding for such an event would come before this Committee, as a Funding Sub-Committee had been established by the Community Council.

As an amendment, Bailie Agnew, seconded by Councillor Brown, moved:-

That the Committee award nil grant to Faifley Community Council, as it was considered that the application did not meet the criteria of the Alexander Cross Cameron Trust.

On a vote being taken, 2 Members voted for the amendment and 5 Members voted for the motion which was accordingly declared carried.

#### Subject: Grant Applications

#### 1. Purpose

**1.1** The purpose of this report is to provide information on a grant application and to recommend a grant to a voluntary organisation from the Alexander Cross Cameron Trust Fund.

#### 2. Recommendations

**2.1** The Committee is asked to agree the grant recommendation for Clydebank East Community Council as per Appendix A.

#### 3. Background

- **3.1** Alexander Cross Cameron Fund grants are administered by the West Dunbartonshire Council and are reported to the Committee as and when applications are received.
- **3.2** The value of fund as at 31 March 2018 was £148,666, which includes interest received during 2017/18 of £522.
