# Subject: Outline Strategic Direction for Cultural Committee

#### 1. Purpose

**1.1** The purpose of this report is to provide the Committee with strategic direction.

#### 2. Recommendations

- **2.1** It is recommended that the Committee:
  - i) note the report
  - ii) approve its outline strategic direction and broad principles
  - iii) request that Council consider shortening the Committee name to Cultural Committee

#### 3. Background

- **3.1** At the Council Meeting on 28 June 2017 membership arrangements for the newly formed Communications, Museums and Cultural Development Committee were agreed. This included confirmation that the Committee had responsibility for Museums, Culture and Arts, Cultural Activities and Council Events, Town Twinning, Corporate Communications and the Town Hall. The Committee will have the power to establish working groups to examine and report on specific issues.
- **3.2** The role and remit of the Committee is to direct and supervise the activities of the Council in respect of Museums, Culture and Arts, Cultural Activities and Council Events, Town Twinning, Corporate Communications and the Town Hall.

# 4. Main Issues

- **4.1** The Committee has been established to further develop cultural activity in the broadest terms across West Dunbartonshire. The fundamental function of this Committee is to promote and enhance the reputation of West Dunbartonshire across Scotland and beyond.
- **4.2** The Communications, Museums & Cultural Development Committee name is considered unwieldy in practice. It is proposed that this is shortened to Cultural Committee with all responsibilities and remits remaining as agreed by Council.

- **4.3** In addition to the remit described in the background section of this report, it is essential that the Committee consider a statement of intent which will outline the strategic direction for this Committee over the coming years.
- **4.4** Given the wide remit across a range of existing services, a proposed statement of intent is:

This Committee holds responsibility for Museums, Culture and Arts, Cultural Activities and Council Events, Town Twinning, Corporate Communications and the Town Hall.

The Committee's purpose is:

- to promote West Dunbartonshire, building on the significant historical and cultural legacy of the past
- to devise future strategy, realising the potential of culture as a key component of economic growth and tourism – activities and events to be explored and developed through working groups
- **4.5** This statement is a starting point for this Committee's activities, and clearly establishes an aspirational intent to build upon.
- **4.6** The Council's Strategic Plan for 2017/22 will be presented to Council later this year, and the work of this Committee will play a role in delivering on the strategic priorities outlined in that document.

# 5. People Implications

**5.1** The Committee will be supported by a range of existing employees. There are therefore no direct staffing implications.
