(a) <u>Mr James Anderson, 28A Riddell Street, Clydebank</u> Installation of Step Lift

We would like to know why my wife is needing a step lift to enable her to get out of our house? We have to apply for a grant and also planning permission before it can be removed from Beeches Road. The Residents are not having to apply for anything, grant or planning permission because they stay in Council property.

My wife has MS which is incurable. Is MS any different if you stay in a Council House when you have to pay for adaptations?

Why don't the local authority when selling land to housebuilders ask them to include two or three houses suitable for disabled people who are not on the Council housing list?

Why when a house was suitable for people with a disability was it restored to a house suitable for a family? How much did it cost to convert it originally and how much did it cost to restore it to a house suitable for a family. It beggars disbelief.

(b) <u>Mr Charlie McDermott, 6 Crannog Court, Milton, Dumbarton</u> <u>Quarries near Milton – Planning Applications</u>

What is happening with regards to the 2 applications submitted by the 2 quarries based near the village of Milton, Dumbarton? I ask this not only for myself but for the many concerned residents of Milton.

As far as I'm aware the quarry at Dumbuckhill has been granted permission to carry out its planned work taking the top off the hill, but when has this work to begin? The other at Sheephill, W. Thompson and Son, again has permission to quarry the whole of Sheephill to within 60 feet of the houses at Miltonhill.

Surely the Council is not going to let this happen what with the ancient ruins on the hill never mind the wildlife, trees etc. Is this planned work going to benefit the residents of Milton, if so can you please explain?
