Subject: HMIE Report on the Educational Functions of West Dunbartonshire Council

## 1. Purpose

1.1 To inform Council of the inspection by Her Majesty's Inspectorate of Education (HMIE) of educational functions of West Dunbartonshire Council.

### 2. Background

- 2.1 HMIE first reported on its Inspection of Education Authorities (INEA) in June 2003. A follow-up to this inspection was published in September 2005 which found there had been very good progress made with three of the main points for action and good progress with the remaining two.
- 2.2 A further inspection as part of the second round of inspections (INEA 2) was announced at the end of October 2008. HMIE surveyed parents, heads of establishment and centrally deployed staff in November 2008 and visited the council for three days in January 2009 to examine evidence provided by the department and plan for the main inspection visit. HMIE spent one week in the council in February 2009 to interview a range of people including Elected Members, the Chief Executive, senior officers in other departments, parents, partner organisations and centrally deployed staff. HMIE spent one day visiting Dumbarton Academy and St Andrew's High School to meet with staff, parents and young people from the schools in those neighbourhoods.

#### 3. Main Issues

- **3.1** The report will be published on 23 June 2009 and is embargoed until that date.
- **3.2** INEA 2 will use a six point scale to evaluate performance as follows:
  - Unsatisfactory (1)
  - Weak (2)
  - Satisfactory (3)
  - Good (4)
  - Very good (5)
  - Excellent (6)

3.3 Although the details of the report are embargoed until 23 June, Council should be aware that senior officers have seen the final draft of the report which was sent for printing and we are in a position to say that the inspection report will be positive and that officers believe it to be a fair reflection of the work of the Department of Educational Services.
