1. Purpose

1.1 This paper seeks Council approval for a response to formal consultation on the future of Policing and Fire and Rescue in Scotland.

2. Background

- 2.1 The Scottish Government has produced two major consultation documents on the future of Policing and Fire and Rescue in Scotland. The consultation documents are available to download in full on www.scotland.gov.uk/policereform and www.scotland.gov.uk/firereform
- 2.2 Formal responses to this consultation are expected to be provided electronically where possible. Attachments to this paper contain the proposed electronic response from West Dunbartonshire Council for both consultations.
- 2.3 In preparing this response, the views of stakeholders were sought including through the Community Planning thematic group Building Safe and Strong Communities. The response also reflects some comments issued by COSLA.

3. Main Issues

- **3.1** Both consultation documents propose structural changes to create national agencies that would be balanced by local structures that would be subject to local accountability.
- **3.2** For the Police consultation the key guestions relate to:
 - o How police reform could improve services and the delivery of outcomes
 - What are the key challenges facing the police
 - How can partnership working with the police be improved
 - How can community engagement be improved
 - What is the right structure going forward
- 3.3 For the Fire and Rescue consultation the key questions relate to:-
 - What is the right vision for the Scottish Fire and Rescue Service
 - What are the right structures going forward
 - How can Ministers and MSPs hold the service to account
 - How can local communities hold the service to account

3.4 For both consultations the key local concern is to protect effective partnership and collaborative working and local accountability. It is also felt important to maintain good working relationships and resources at current levels, irrespective of the national structures.
